Kikkoman Announces Status of Acquisition of Own Shares

(Under the provisions of Kikkoman's Articles of Incorporation pursuant to Article 165-2 of the Companies Act of Japan)

Kikkoman Corporation ("the Company") announces that it has executed to acquire its own shares under Article 156 of the Companies Act of Japan, as applied pursuant to Article 165-3 of the Companies Act. The details of the share acquisition for August 2025 are as follows.

1 Acquisition period : From August 1, 2025 to August 31, 2025
2 Number of shares acquired : 1,727,000 shares
3 Aggregate amount of acquisition price : 2,263,557,736yen
